This is a six lane, 25 yard pool with a separate warmup area. Automatic timing will be used. Spectators may bring chairs. There is ample parking nearby. The competition course has been certified in accordance with 104.2.2C(4) . The copy of such certification is on file with USA Swimming & Georgia Swimming.
- Concessions:** A variety of food and drink will be available
- Rules:** The current USA Swimming Rules will govern the conduct of the meet.
- Entry Fees:** \$3.00 per individual event; \$6.00 per relay. Make check payable to Americus Blue Tide
- Eligibility:** Open to all summer recreation swimmers and invited USA Swimming athletes. USA-S coaches and officials will be required to show current certification.
- Entry Limit:** Swimmers may enter up to five (5) individual events and two (2) relays.
- Entries:** E-mail a Hy-Tek or SDIF entry file to coach@americusbluetide.com. Summer recreation teams may submit handwritten entries. Entries will not be considered final until a check for the entry fees is received.

- Deadline:** All regular entries must be postmarked no later than Wednesday, May 27.
- Late Entries:** Late entries will continue to be accepted through the day of the meet for any open lanes at double the normal entry fee.
- Seeding:** All events will be pre-seeded.

- Format:** All events will be timed finals, with warmups starting at 8:30 a.m. and competition beginning at 10:00 a.m. All age groups will be seeded in combined heats, but will be scored separately.
- Age Control Date:** Swimmers will compete according to their age on June 6, 2009.
- Warmup:** The Georgia Swimming, Inc. approved warmup guidelines will be followed.
- Scoring:** Scoring will be for the top 6 places in each of the following age groups: 6&U, 7-8, 9-10, 11-12, 13-14, 15&O. The following points will be awarded: 7-5-4-3-2-1. Relay points will be double the above.
- Awards:**
Ribbons: 1st – 6th individual and 1st– 3rd relays
Trophies: Individual High Point awards for each age group
- Officials:** The meet Referee will be Bruce Adams (beadams1@yahoo.com). The meet Safety Chairman will be Anna DeMott. All certified officials are welcome to work at the meet. Please contact the meet Referee 10 days prior to the meet if a specific assignment is requested. Once at the meet, report to the Referee 30 minutes prior to the session.
